#### **Business Reopening Guidance**

While workplace re-entry plans should be unique to each business, this document serves to connect business leaders with helpful resources and information to frame a safe return plan. Relevant recommendations from a variety of resources are referenced throughout the guide and businesses are encouraged to consult trade association guidance and other industry-specific regulations as well.

Reopening Business: Digital Resources & Sector Guidance

It is recommended that businesses reopen operations in several phases, created and modified to uniquely fit each organization. This phased approach is based on guidance from the Federal Government and the Centers for Disease Control and Prevention (CDC). #### **Federal Guidelines for Opening Up America Again**

The Lincoln Chamber of Commerce, in partnership with the Nebraska Chamber of Commerce & Industry, Greater Omaha Chamber of Commerce, State of Nebraska, University of Nebraska and other local partners, gathered results for the COVID-19 Nebraska Business Survey Report. Over 4,500 responses were collected from Nebraska businesses. The responses illustrate the impact of the current pandemic on workforce in our state and highlights opportunities to best support businesses and nonprofit organizations as we rebuild. The Nebraska Chamber of Commerce & Industry, Lincoln Chamber of Commerce and Greater Omaha Chamber of Commerce joined forces to promote strategies to elevate workforce programs and increase regulatory certainty. # **Mayor's Economic Recovery Task Force**
